THIS DEED OF DECLARTION OF PUNBLIC CHARITABLE

TRUST WITNESSETH AS UNDER:

- 1. The name of the trust shall be ST. MARY'S EDUCATIONAL AND CHARITABLE TRUST and its office for the present shall be located at 201/4, Anna Complex, IAF, Avadi Chennai –600 055 and or such other place or places the trustees herein may decide from time to time.
- 2. The object for which this public charitable trust is founded are as under:
 - a) To render developmental, social and spiritual advancement for woman, children, handicapped and others irrespective of religion, caste, creed, sex, color and race, in order to fulfill the charitable and educational needs of the society in general and to help the downtrodden weaker and lower section of society.

- b) To develop the rural areas, by helping villagers to come up in life by engaging themselves in Arts, Crafts, Education Institutions, Cottage Industries and small scale Industries, Vocational training, Health and Welfare.
- c) To undertake and co-ordinate social ameliorative educational and relief work for the public in general and run homes for poor, destitute and old age homes irrespective of caste, creed and religion.
- d) To make the people useful citizens of India by developing their body, mind and soul and imbibe in them good citizen, so as to become Ambassadors for the good of mankind.
 - e) To develop educational Institutions and to create job opportunities for the poor and the needy.
- f) To assist people; to initiate, organize, establish and promote developmental programs and projects aimed at relief, rehabilitations, and development of the poor of all castes and creeds, and to create and awareness in them to improve their socio-economic status.
- g) To organize and encourage educational and health programs, both in the formal and informal sectors, by establishing educational/Medical institutions and promoting vocational/technical training.
- h) To arrange scholarship and sponsorship programs for eligible students to pursue their studies.
- i) To establish and maintain youth hostels, old age homes, orphanages and creches for children.

- j) To promote infracture facilities like conference centers, seminar halls, libraries and documentation centres, recreation and entertainment facilities.
- 3. The trust will have 3 trustees on the board:
 - a) Chairman/Managing Trustee. GIRISH
 - b) Secretary. JANE G
 - c) Treasurer. CHRISTING & CAROLINE
 - (i) Chairman/ Managing Trustee:

The Chairman/Managing Trustee shall be the Chief Executive of the Trust, who can sue and be sued. The term of office of the Managing Trustee shall also be for five years. Not more than three terms shall, the office of the Managing Trustee be held continuously by the same person. The Managing Trustee shall be one of the cosignatory for their operation of the bank.

(ii) Secretary:

The Secretary of the Trust shall manage day today affairs of the trust, subject to superintendence, guidance and control by the Board of Trustee. The Secretary shall be one of the co-signatory.

(iii) Treasurer:

The treasurer shall be in charge of the finance, subject to the direction and control of the Board of Trustees. The Treasurer shall always be one of the cosignatory.





- 5. The funds of the Trust are as under:
 - (i) The initial contribution of Rs.1000/- as aforesaid and further contribution to corpus.
 - (ii) Any income from the corpus.
 - (iii) Any other contribution that may be received by the Trust from time to time.
 - (iv) Any income raised by any fund raising projects.
- 6. The funds of the Trust are hereby vested with the trustees of the Trust.
- 7. The funds of the Trust may be invested in Bank deposits, Government Bonds and also in any other manner as may be permitted by the Income Tax Act from time to time.
- 8. The income should be utilized only for the furtherance of the objects of the trust.
- 9. Proper account shall be kept for funds, properties and income of the Trust. Accounts should be closed every year for the period from 1st April to 31st March which shall be audited by a chartered Accountant from time to time:
- 10. The trustees are authorized to acquire both movable and immovable properties for the objects of the Trust and such property shall be administered by the Board of Trustee.

11 The Trustees are authorized to open bank account which may be operated by the Treasurer along with the chairman cum Managing Trustee or the Secretary.

12 The Board of Trustees are empowered to borrow funds for the objects and purpose of the Trust from Banks, Financial institutions and others with or without securities and for that purpose to enter into any agreement, Deed, document and also to offer as security any of the movable or immovable properties of the trust However any such borrowings above Rs.5 Lakhs, shall be approved by the general body of the author of the trust.

13.In the case of any doubt with the interpretation of the trust deed ., Trust Act shall be bind.

14. It is hereby declared that any amendments to the object of the trust or the Deed of the Trust by the Author of the trust shall be made effective only after approval there of is obtained from the concerned Commissioner of Income Tax/Director of Income Tax (Exemptions) as the case may be.

15. The funds and income of the Trust shall be solely utilized for the objects of the Trust and no part of the income to the benefit of the author of the Trust of trustees either directly or indirectly.

16.In case the Trust is to be wound up the funds and properties of the trust shall be transferred to another charitable Trust having more or less similar objects.

17.this Trust is irrevocable.
